D3D22 Handrails

Delete (1)(f) and insert (1)(f) as follows:

- (f) in a *required exit* serving an area *required to be accessible*, be designed and constructed to comply with clause 9 of AS 1428.1, except that clause 9(d) does not apply to a handrail *required by (1)(c)(ii)*.

Part D4

D4D4 Parts of buildings to be accessible

Delete (a) and insert (a) as follows:

- (a) every ramp and stairway, except for ramps and stairways in areas exempted by D4D5, must comply with—
(i) for a ramp, except a *fire-isolated ramp*, clause 7 of AS 1428.1; and

- (ii) for a stairway, except a *fire-isolated stairway*, clause 8 of AS 1428.1; and
- (iii) for a *fire-isolated stairway*, clause 8.1(f) and (g) of AS 1428.1; and

Delete (f) to (h) and insert (f) as follows:

- (f) a ramp complying with AS 1428.1 or a passenger lift need not be provided to serve a *storey* or level other than the entrance *storey* in a Class 5, 6, 7b or 8 building—
 - (i) containing not more than 3 *storeys*; and
 - (ii) with a *floor area* for each *storey*, excluding the entrance *storey*, of not more than 200 m².
